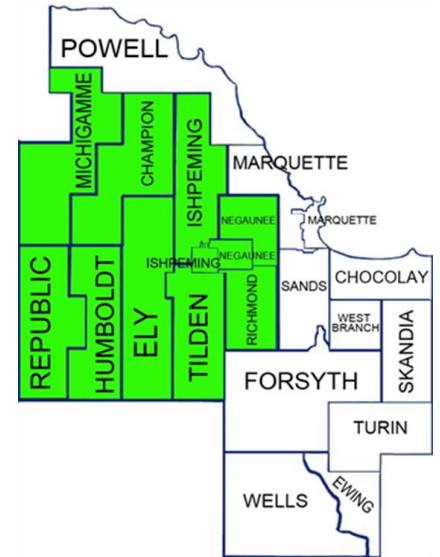

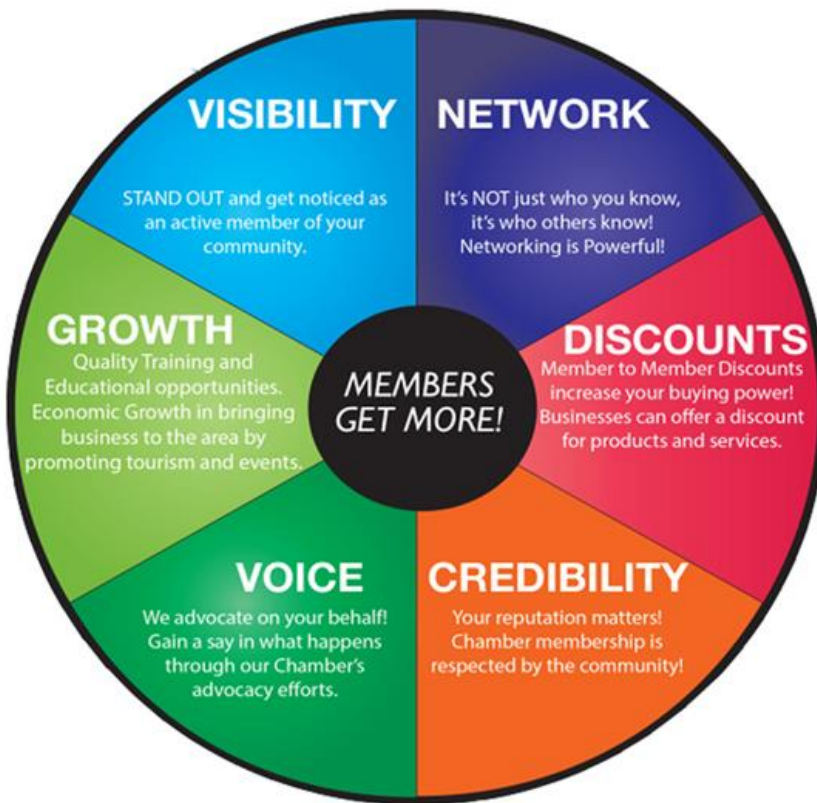
Fulfilling Our Mission:

GINCC Membership Dues

The base fee for any organization or business is **\$150/year** (including non-profit, healthcare, associations, organizations, general businesses). The first five (5) employees are free, with \$5 per additional full time employee.

Educational Institutions: \$180 **Lodging:** Base fee + \$5/unit **Apartments:** Base fee + \$2.50/unit

Municipalities: \$300 + .005% assessed taxable value **Utilities:** Base fee + \$5/1 MIL deposit

Multiple businesses/locations discount: \$150 first business, \$120 second, \$60 each additional
